From the Supervisor's Desk

Happy Holiday's! Hope everyone's Thanksgiving was festive! Now let's get ready for Christmas.

To keep you up to date, Water District 6 is complete. Water District 7 is at the comptroller's office for approval. Water District 8 looks very good with overwhelming yes signatures. Districts 9 and 10 are in the beginning stages with income surveys circulating to see how much grant money we are eligible for.

As you may have heard at the November board meeting, we have passed a bond resolution for a MUCH needed, unsafe, inefficient in energy and size, highway garage. The garage was built in the 1950's and the trucks have gotten much larger since then, making our garage inadequate and unsafe. Last summer the Town formed a committee to work with engineers and architects. After many meetings and brainstorming, it was determined that the most economical solution would be to demolish the existing five South bays and rebuild. There was a public hearing on this subject last month and the engineers and architects answered every question that was brought to them. I understand that a Town resident is forcing a permissive referendum, which means the public will have to vote on this matter. This vote will cost the Town taxpayers thousands of dollars. This Town resident feels that it is better to try to renovate the existing building, even though the engineers have already deemed this not to be practical and not cost effective. The building the committee is proposing is a bare bones box with one overhead crane. Much of the work will be done in house to keep cost down. This building has not been structurally updated in the last 60 years; it has been talked about, but nothing done. How many people can say they still work or live in a building that has not been updated for 60 years? We are grateful for everything our highway men do, and at the end of the day we want them to all go home safely to their family.

Christmas wreaths and lights will be going up soon. Hope everyone has a happy and healthy holiday.

Merry Christmas! And again, please try to attend monthly meetings, which are the second Wednesday of every month at 7:00PM. This is your town.

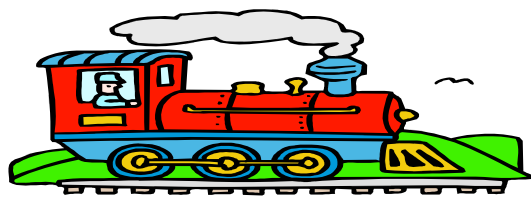
Highway Superintendent

Hello...I'm hoping everyone had a Happy Thanksgiving and is getting prepared for Christmas. I would like to say thank you to the residents of Byron for using their winter driving skills. I (we) didn't really see any accidents, and none were serious that we are aware of. Please continue to allow yourself extra time to get to where you're going, and please drive at a manageable speed.

Next, I would like to address the issue of the new building proposal. First, ask yourself how many of us are still conducting things the way they were handled 60 years ago. This building is a testament to how well it was built, but it has served its purpose. The initial talks for replacement were started 40 years ago from what I've heard, yet nothing was ever done. A few updates in lighting and heating due to some incentive money from the utility companies, but while the equipment got bigger the "shell" of this building has remained the same, block walled with no insulation and the occasional paint job to make the outside look better. The engineers and architects have studied and restudied the possibilities for rehabbing, but keep coming to the same conclusion, it's just not cost effective to try to use the same building. Nothing is updated to codes and the physical size is just too small. It needs to be removed and replaced. Please feel free to educate yourselves to this situation, and come and view the building now that all the winter equipment is on. Trucks have to be pulled in and out at an angle because the building can't "house" them straight on. Holes have still been punched in the block to make things fit. When we work on a truck usually one or more trucks have to be moved out due to a lack of spacing between trucks. Again, feel free to stop by and look or view the proposal in the Clerk's Office. Borrowing money is as cheap now as it's been, and continuing to wait is only driving the cost up as it has done for the last 40 years. The other concern is for the safety of the Town workers. We've been quite fortunate to this point that there haven't been any incidents, but the more this structure is in use, the greater the chance that something could potentially happen. So again, I ask you how many things are you doing exactly the same even though everything has changed around you in the last 60 years. Please educate yourselves and feel free to stop in the "shop" or look at the proposal pictures which has current conditions listed.

Thank you for your patience in the winter and Merry Christmas.

A committee representing the Byron-Bergen School District, the Byron and Bergen Communities, and the Byron-Bergen Library is partnering up with the Richter Family Foundation to bring the Imagination Library to our children. Skivvies, Spirits and a Sword Swallower!

On Sunday, November 6th at the Byron Fire Hall the 2nd Annual Spirit and Skivvies Event was held. This unique event was started by Wendy Frongetta who was joined by her husband, Tony and Dawn Anderson in honoring Dawn's son and their good friend, Mikel Anderson. Mikel passed away in 2015 of an accidental drug overdose. Although Mikel struggled with addiction, he was in recovery and he dedicated his life to helping others and those who helped him. Wendy, who knew and loved Mikel wanted to do something in his name to continue his helping spirit by helping those battling addiction, many who are homeless. Wendy approached the shelter, the Kahler House, that Mikel loved in Lockport and asked them how she might help others struggling with the same issues that plagued her friend. In doing so she learned that the first thing that happens when someone enters a shelter is that they are asked to shower and are given new clothes. In every instance their undergarments are tossed out. She learned that most shelters had donated clothes, but were always in need of new undergarments.

Last year Wendy and Tony Frongetta contacted their many friends, who contacted their friends and they gathered at their Byron home for a party of giving. Family, friends and friends of friends got in the spirit of things and happily joined the Frongettas bringing their donated packages of new undies. The result was overflowing baskets with socks, undershirts, bras and skivvies in every color and size. Wendy stressed that not only adults find refuge in homeless shelters, but sadly many families in our area can sometimes find themselves homeless. The plea to gather all sizes of undies was embraced by their friends and the Frongettas proudly donated all the collected skivvies to Lockport Cares, Inc. and the Kahler House.

This year word of Wendy's good deed gathered momentum and other folks jumped in to help. The Byron Fire Hall donated the space so that she could reach out on a bigger scale. Wendy's children Joe and Gina Schelemanow as well as Mikel's mom, Dawn, and sisters, Cassandra Anderson and Rebecca Rosten, donated help on November 2nd.

Wendy shared her goal with Steven Foster and Tim Adams, co-owners of the Red Osier Restaurant and they made the event even more of a party by generously donating many of the needed party items including the great food, and wine. During the event, there was a 50/50 drawing, a silent auction and some vendors set up to show and sell their wares.

Ted Werner, who is both on the board of Lockport Cares, Inc. and the program manager at the Kahler House, spoke of the need to support individuals in our community. Werner mentored Mikel, and he spoke about the organization's mission, "To prepare residents for a productive lifestyle and to help ease the transition back into a healthy life style supported by faith in Christ." In addition, he spoke of Mikel and his important role in helping so many people struggling with addiction.

The multiple clothes baskets over-flowing with undies in every size and color lined one wall and Wendy happily thanked those who attended and donated. The skivvies that were collected on November 2nd will be donated again to Lockport Cares, Inc., the Kahler House, Community Action in Genesee and Orleans counties, area half-way houses, sober-living facilities, battered women's organizations and veteran's organizations in our community. This will be an annual event and Wendy hopes that with plans of next year's 3rd Annual Spirit and Skivvies Event she can help even more people.

Genesee County Legislator, Robert Bausch

Following the November elections, there will be some new county officials in January. Last December County Court Judge Robert Noonan retired and Supreme Court judges from Buffalo have been presiding in county court. To replace Judge Noonan, Charles (Chuck) Zambito, currently county attorney, was elected. Chuck was my predecessor on the legislature from District 2 and I have enjoyed working with him as the county attorney. He will be an excellent jurist. Kevin Earl has accepted the position of county attorney

Longtime Sheriff Gary Maha is retiring on December 31st. Bill Sheron, currently the Undersheriff and very dedicated to law enforcement, was elected as the county sheriff. I have worked with Bill while serving on the legislature and he will do an excellent job. Greg Walker will be appointed as the new Undersheriff.

As this is being written, my desk is covered with financial information relative to the 2017 county budget. There is absolutely no good news on that front. Currently the legislature is looking at a 4.5% - 6.5% tax increase. After holding the tax rate steady for a number of years, with a decrease in 2015, it is impossible to continue at the current rate. The budget shortfall is approximately two million dollars. If not for the anticipated sale of the nursing home it would be four million dollars. A number of factors are responsible for this deficit. On the revenue side, limited growth in property values and flat sales tax receipts are the main culprits. But the real problem is expenses.

As discussed in previous newsletters, approximately 80% of county property taxes are allocated to the state's insatiable requirement for mandated services. For 2017 under the NYS "2%" tax cap legislation, Genesee County was only allowed to raise property taxes by 0.6% with no mandate relief as required by this same legislation. In fact, the state mandated salary increase for the district attorney exceeded the amount the county was allowed to increase property taxes without passing override legislation. The county must pass override legislation or take the extreme risk of insolvency.

All of this said, I can assure you that all the legislators take their fiduciary responsibilities seriously and appreciate the impact a tax increase will have on county residents.

In the coming weeks you will be hearing about 911 funding. The issue is not a revenue issue. All residents with land lines and most with cell phones are paying for this service. However, over 50% of the funds raised by the 911 surcharge are being diverted to other programs. The result: 911 services in NYS are sadly obsolete and need updating.

In closing, I would like to wish everyone Merry Christmas and Happy New Year and I look forward to serving District 2 residents in the coming year.

Town of Byron Comprehensive Plan Update

The Town of Byron is working on an update of the Town's 1993 Comprehensive Plan. The Comprehensive Plan is a document that guides and controls future growth and development in the community. It looks at the Town's existing conditions and past trends, and sets forth a vision for the future, along with strategies for how to improve conditions in the Town. Under New York State law, the Comprehensive Plan is the primary basis for the Town's zoning. The Plan will also help the Town identify important projects, obtain grant funding, and coordinate with the County, the region and the State.

One of the most important steps in updating the Comprehensive Plan is getting public involvement. We want to be sure the plan reflects the community's vision for Byron's future. The Town will be hosting a public information meeting on Tuesday, January 17th at the South Byron Fire Hall to get your input. The doors will open at 6pm, and the project team will be available for informal questions and discussions. A brief presentation will begin at 7pm, followed by the opportunity to voice your opinion and ask questions. We hope to hear from you about the major issues the Town will face over the next five to ten years. What are your concerns? What are your priorities? What should the Town's priorities be?

Over the course of 2017, there will be additional opportunities to provide input. The Town will be conducting a community values survey. There will also be a second public information meeting later on in the year to summarize initial recommendations for public feedback. DEATH IN THE KLONDIKE

DREAD MESSENGER CLAIMS A GENESEE COUNTY VICTIM.

Charles Tyler, Who Went From South Byron With the Gillett Party on March 7th, Succumbs to Typhoid Fever After an Illness of Only About a Week.

Death has claimed its first victim among the pilgrims from Genesee county to the Klondike. Charles Tyler, who went from South Byron early last spring, died from typhoid fever in the Sulphur Creek district; about thirty miles from Dawson City, about October 1st. The exact date of death has not yet been learned. The news of his demise was received in Batavia yesterday afternoon. It was imparted in a letter received by Miss Hattie Fox, who lives at F. I. Judd's on State street, from Edward Votry, a Bethany young man who went to the northeastern gold fields last spring. The letter is dated October 3rd and was written at Dawson City.

"I have some very bad news to tell you," Mr. Votry writes. "Charles Tyler, who was one of the Gillett party, is dead. He was a very nice young fellow. He died from typhoid fever and had been sick only a week. We held funeral services at both the cabin and the grave. Edwin Frazer, Bert Menzie and Dr. Guile sang. Another doctor, whose name I do not remember, read from the Bible and offered prayer. H.H. Scott of Batavia, Charles A. Anderson of Elba, John Blair of Byron, Alden Smith of Clifton Springs, Wendell Prentice of Batavia and myself were the bearers. He was buried on claim No. 20 above Sulphur Creek. It is a nice place and in the spring we will make a fence around it and fix it up nicely. We are going to have some photographs taken of it to bring home. The doctor wrote a very nice letter to his mother, but it must be awful for her to read. He had as good as care he could have had at home. Two doctors were with him all of the time and Cleve and Will Gillett and all of the rest of the boys did all that could be done."

Mr. Votry wrote that all the rest of the party were well.

Mr. Tyler, who was 20 years of age, was a son of the late Winfield Tyler of Stafford and a grandson of Warren J. Tyler. He was born in Stafford, where his father died about 12 years ago. His mother, who is a sister of E. J. Gardner of Batavia, married Andrew Vanderhoff of Stafford a few years after her first husband's death and about seven years ago they removed to Maple Rapids, Mich. Since that time Charles had lived a part of the time in Michigan and had spent the balance with relatives in this county.

Young Tyler left for the Klondike on March 7th of this year from South Byron, in company with Cleveland M. and William H. Gillett and John Blair of that place, to all of whom he was distantly related by marriage. There were many people at the Batavia station to see the party pass through and the remark was made by several that Mr. Tyler seemed to be the best fitted of the four to withstand the rigors of the Klondike climate.

He was a fine specimen of manhood and seemed to be in perfect health. Besides his mother he is survived by an older brother, Lester, who lives at Maple Rapids. He was a nephew of A. W. Tyler of Batavia.

The mother of C. M. and W. H. Gillett received a letter from them recently, dated September 15th, stating that all of the Byronites were well at that time.
