WASTE WATER REPORT – Robert Cudney:

On Monday, March 24th, the new pickup arrived in Byron. The vehicle arrived with all options specified in the approved proposal from December 2007. NYS increased this regions delivery allowance on November 1, 2007. VanBortel Ford did not receive notice of this change until January 2008, after our vehicle was ordered. There is a \$15 increase to our original proposal. Attached to the invoice is page 5 of the NYSOGS contract verifying this change. The ladder/safety light bar was added to the truck since its arrival. When I return from vacation the 2-way dispatch radio and tool boxes will be transferred to the new truck and put on the road.

·1997 Chevy pickup – the new pickup has arrived in time for the upcoming municipal auction. I have talked to Cindy Wolcott, Municipal Sales Manager for Roy Teitsworth, Inc., and discussed the vehicle with her. She had mentioned two options available for the sale of the pickup: online or take to live Palmyra auction. She has sent me some information on both and I have left copies in all your boxes for you to look at. I do know that for many years past, the Palmyra auction has consistently worked very well for the Town of Byron. Although this truck has 135,000 miles on it, I do believe it will clean up decently and may be a greater value if it is seen. The May 10th Palmyra auction is prior to the next board meeting, so direction tonight is recommended. An estimate from Cindy ranged from \$2,700-\$4,000 on the phone. The online auction handled by Teitsworth runs for seven days, once per month usually starting the first Wednesday of the month. This particular service is too late if we decide to take it to Palmyra.

·Wet weather and melting snow for most of the month contributed to exceedances in flows at all facilities. We were able to maintain compliance to all other analytical reporting.

·Notification to district residents where septic tanks will be attended to were sent out on April 2, 2008. This will hopefully begin by the end of the month.

WATER DISTRICT NO. 2 UPDATE – Eric Wies:

TOWER HILL ROAD UPDATE:

·Richard Mathes would like to know how many water units will be assigned to his property. Uses approximately 800 gallons of water during a peak week. Usually uses between 400–800 gallons a week.

Councilman Tom Felton - The average household uses 180-200 gallons of water a day. It is his feeling that the Pumpkin Hill Veterinary Clinic should be assessed one unit of debt service.

Eric Wies - A separate water district may need to be formed for the Pumpkin Hill Veterinary Clinic for paperwork issues.

At last month's GAM meeting the Supervisor's from each town were asked to pass a resolution opposing the "Hoyt Bill", which would require development projects funded by the primary economic development entities in NYS to pay contractors prevailing wage.
