Councilman Ferguson: Used ordinances from other towns to create the proposed Town of Byron Water/Sewer Ordinance. Tap size determines unit charge, i.e. a one inch tap would be charged one water/sewer unit. This is a rough draft and the committee will be meeting again to review/make changes to the proposed ordinance.

Councilman Ivison: Is it the intention of this ordinance to change the units/debt service charges for the water districts that have already been established?

Supervisor Felton: It could be done, the bond holders would just need to be notified that the number of units has changed. He would like to readdress this after the committee has met again.

#### **UNSAFE BUILDINGS LAW:**

•The CEO/ZEO is in the process of addressing the unsafe building situation on Mechanic Street. He does not believe this property falls under the Unsafe Building Law. Supervisor Felton will work with the CEO/ZEO and the Town attorney to try to resolve this issue.

#### <u>PARK COMMITTEE REPORT – Supervisor Felton:</u>

•Installed horse shoe pits in Firemen's Park. •Non-profit groups will not be charged rental fees •Trestle Park vandalism was addressed and repairs made •DEC will be visiting park at least three times during the week •Formed a subcommittee under the Park Committee •Reducing number of committee members to nine members

Supervisor Felton: He is concerned about the continued vandalism and whether it is an asset or liability to the Town. He has spoken with the Town's insurance company. He would like to see the gates closed at dusk, no open burning and no camping. Jim Renfrew, the Park Committee Secretary will review Supervisor Felton's suggestions with the Park Committee.

The remainder of the Town Board expressed their concern over the Town's liability with regard to Trestle Park.

#### **GRANTS:**

Environmental Protection Fund – money for park development and preservation – Supervisor Felton forwarded information to Jim Renfrew. Supervisor Felton also sent information to Jeff Maurer for possible use at Robins Brook Park. The Town of Bergen might be interested in pursuing grant with the Town of Byron.

#### WATER DISTRICT NOS. 3 & 4:

•Met with Dawn Kuras from USDA on Wednesday, August 5<sup>th</sup> regarding funding. Have been approved \$156,000 2.625% interest for 38 years.

Ivison \$143,000

The cost will probably be approximately \$20,000 more for each district. The goal is to go out to bid in September and open bids in October. If bids are high, the Town will need additional USDA funding and Comptroller approval, another Public Hearing will also be required. The Town will need to go back to USDA to ask them to fund the gap. If everything goes well, digging could begin in the spring.

# **RESOLUTION #57:**

*WHEREAS*, the Town does not have sufficient funds on hand to pay for all the construction of the Water District,

*WHEREAS*, this project may be eligible for federal government funding through the USDA/Rural Development to construct the Water District,

*WHEREAS*, it is in the interest of the public to obtain low interest loans and/or grants for the construction of the Water District; therefore be it

**RESOLVED**, that the Supervisor and Deputy Supervisor of the Town of Byron is authorized to cause an application to be prepared to obtain funding from USDA/Rural Development and

**BE IT FURTHER RESOLVED**, that the Supervisor and Deputy Supervisor be authorized to execute all application documents and forms required to determine funding eligibility and to obtain specific funding for the project from USDA/Rural Development.
